

# **BLACK FIRDAY - PRIZE DRAW REGULATIONS**

#### I. Organiser Information

The organiser of the game: Pepita Group Zrt. (hereinafter referred to as the *Organiser*)

#### II. General Provisions

This regulation applies to the 2024 'Black Friday' prize draw organized by Pepita Group Zrt. The 'Black Friday' prize draw is a lottery-type game, the essence of which is that in the event of the participant meeting the conditions set out in Section III on the websites pepita.hu or pepita.com, or any international versions thereof, between 06:00 on 28th October 2024 and 23:59 on 7th November 2024, and declaring his or her intention of participating in the prize draw, he or she shall take part in the draw, with the chance of winning the prizes set out in Section VII.

The specific provisions, conditions, and rules included in the invitation for the prize draw, along with this regulation, constitute the full set of rules and regulations governing the prize draw. In the event of any inconsistencies, the rules or provisions set out herein shall be deemed valid.

The Organiser reserves the right to modify these participation rules, to shorten or extend the duration of the game, and to make other changes.

The organizer reserves the right to suspend the announced prize game, modify these participation rules, shorten or extend the duration of the game, or make any other changes to the game at any time. In the event of a modification to the rules for an already announced prize game, the organizer will notify participants who have already registered via email. In such cases, participants also have the right to request their removal from the participants' database.

### III. Terms and Conditions of Participation

Any natural person who has full legal capacity, is over the age of 18, and a resident of the European Union, as defined in the invitation, may participate in the prize draw, unless he or she has been excluded from participation under any other regulations. Participants shall accept the terms and conditions of this regulation and data processing rules as binding, provide their email address and full name, consent to the organizer publishing their name if they win, and meet the other conditions for the prize draw.

A condition for participating in the prize draw is subscription to the newsletter available at https://pepita.com/black-friday and sharing of this website on Facebook. For the purposes of the prize draw, subscribing to the newsletter is considered valid when done by using the 'subscribe to the VIP list' button on the 'Black Friday' website, or by confirming the subscription through the link sent to already subscribed users. The requirement to share the website is considered fulfilled for the prize draw if the player uses the share

button available on the website to complete the sharing. By subscribing to the newsletter, the participant hereby acknowledges that he or she consents to the Organizer sending out newsletters and other marketing correspondence. The participant may revoke such consent at any time by contacting the Organizer, but in the event of revoking his or her consent before the draw takes place, the participant shall lose the opportunity to participate in the prize draw.

The player will participate in the 'Black Friday VIP 2024' prize draw if they meet both the newsletter subscription and sharing requirements.

A natural person is only eligible to enter a prize game once. If the same individual registers multiple times, the organizer will invalidate all entries associated with that person. In the event that the participant is selected in the drawing, the organizer will verify any duplicate entries associated with that participant.

Individuals who cannot participate in the prize draw include the Organiser's executives, employees, and their relatives as defined in Section 8:1 (2) of the Civil Code. Relatives include close relatives, partners in life, direct relatives' spouses, the spouse's direct relatives and siblings, as well as the sibling's spouse.

### IV. The process of the prize draw

Players who meet the conditions outlined in section III will participate in The draw specified in section V, where they can win tangible prizes. Information about the prizes can be found in the appendix to the rules.

In addition to the tangible prizes, the Organizer may, at its discretion, reward certain players with personalized shipping privileges that can be used during purchases from the Organizer.

# V. Winner Selection

Within 3 working days of the end of the prize draw period, as indicated in the invitation, the organizer shall randomly select the winner from among the participants by means of a draw. The draw shall not take place in the presence of a notary.

The organizer shall notify the winner by displaying his or her name on the Pepita website and on the organizer's Facebook and Instagram pages, and directly via email. The winner is entitled to claim the prize up to 3 days after receiving email notification – or 7 days if no new winner has been drawn.

### VI. Drawing a New Winner

The Organiser reserves the right to draw a new winner if the original winner does not claim his/her prize within 3 days (by the 24th hour of the 3rd day after the winner's announcement) or cannot be contacted, or to close the prize draw without drawing a new winner. On the 3rd day following the drawing - or on the 7th day if no new winner is drawn - the original winner loses his/her right to the prize.

#### VII. Collection of the Prize

The organizer will send the prize by courier within 3 business days after the winner's claim, to the address specified by the winner, which must be within Hungary or the European Union according to the announcement. The winner is responsible for receiving the prize. If the delivery of the prize fails, the organizer will only resend it after the associated costs have been paid. If the prize delivery is not successful within 30 days of the initial dispatch, the winner will forfeit their entitlement to the prize.

The condition for receiving the prize is that the winner consents to the organizer processing their data for five years from the date of receipt.

Upon receiving the prize, the winner is required to provide proof of identity. Refusal to do so will result in the failure of delivery, which may lead to the forfeiture of the prize.

# VIII. Data Management

Participation in the game and the provision of the necessary data is voluntary. Pepita Group Zrt. handles personal data confidentially according to the provisions of Act CXII of 2011 on the Right to Informational Self-Determination and Freedom of Information, based on the authorisation received from the Players and within the relevant legal frameworks. Data will not be transferred to third parties other than the data processor. By participating in the prize draw, the Player consents to being contacted by Pepita Group Zrt. for direct business acquisition or marketing purposes.

Players have all the rights defined in Sections 14-25 of Act CXII of 2011 on the Right to Informational Self-Determination and Freedom of Information concerning the data used by the data manager. They can enforce their claims in court or contact the National Authority for Data Protection and Freedom of Information.

If a Player does not wish for their data to be used in the future, he/she can request the deletion of his/her data from Pepita Group Zrt. in writing by providing his/her name and address via postal mail (Pepita Group Zrt., address: 5520 Szeghalom, Pepita utca 3. or by e-mail (segitunk@pepita.hu) or through the link at the bottom of the e-mail, except for mandatory data management for winners.
