

"Black Weeks" Regulations

- 1. These regulations (hereinafter: Regulations) set out the deviations from the current General Terms and Conditions of Use of Pepita Group Plc. (registered office: Pepita u. 3., 5520 Szeghalom, Hungary; Company Registration Number: 04-10-001650; registering court: Gyula Regional Court as Court of Registration; Tax Number: 27124253-2-04; webform: https://pepita.com/en/contact; business postal address: Pepita utca 3., 5520 Szeghalom, Hungary, hereinafter: Organizer), as well as special provisions related to the "Black Weeks" promotion (hereinafter: Pepita Black Weeks or Promotion) announced by the Organizer for the period between November 8, 2025, and November 30, 2025. Accordingly, the provisions of these Regulations are only applicable to and relevant for the transactions and commercial practices affected by the referenced Promotion.
- 2. The Pepita Black Weeks will take place from November 8, 2025, to November 30, 2025. Within the framework of the promotion, the Organizer will sell designated products at the promotional price indicated in its commercial communications. The Organizer will mark the products included in the Promotion with a "Black Weeks" logo on the pepita.com website. Products not marked as such do not participate in the Promotion.
- 3. The Promotion applies exclusively to those items available in the pepita.com webshop that have been designated by the Organizer for participation in the Promotion as defined in Section 2. The Organizer notes that for some products, only certain variants (e.g., color, size, packaging) are part of the promotion. As an online marketplace, the same product may appear on pepita.com in the offers of multiple sellers. The promotional price applies only to those offers that have been marked as promotional by the Organizer or its designated partner within the framework of the promotion.

It may occur that the total stock of a given product exceeds the quantity allocated for the promotion. In this case, the promotional price is valid only for the quantity allocated to the promotion; the remaining stock will be sold at the non-promotional price during or after the promotional period.

- 4. The Organizer includes certain products in the Promotion at a promotional price with limited stock (promotional stock products). The minimum quantities of promotional stock products that the provider commits to selling at a promotional price within the Pepita Black Weeks can be tracked on the product pages of the respective items. The Organizer expressly informs customers that it reserves the right to sell a higher quantity of products than specified on the product pages at a promotional price, but makes no commitment to do so. Consequently, promotional stock products may sell out well before the closing date of the promotion specified in Section 2.
- 5. During the Pepita Black Weeks period, the range of promotional offers changes dynamically. The Organizer reserves the right to add new products to the Promotion during the campaign period and to end the promotional sale of certain products once the promotional quantity has been depleted.

Accordingly, it may occur that certain products are not yet available at the beginning of the promotion or are no longer available at a promotional price in a later phase of the campaign.

The promotional period will not be displayed on the product page; however, only currently discounted products will be shown on the Pepita.com "Black Weeks" campaign page. The Organizer undertakes to remove the "Black Weeks" marking from any product that is no longer part of the promotion, thereby clearly indicating that the product is no longer part of the campaign.

- 6. The images of the products included in the Promotion are for illustration purposes only. The delivered product may differ slightly from the product depicted—not affecting its essential properties—provided that the product must always correspond to the listed product specifications.
- 7. The Organizer is entitled (but not obligated) to refuse purchase offers from a customer who has already purchased at least one unit of the given product type included in the Promotion.
- 8. The Organizer does not reserve products placed in the shopping cart by the customer from its inventory; placing an item in the cart does not constitute an order. Therefore, a product may become unavailable even after the customer has placed it in their cart. The formation of contractual legal relationships regarding the product shall be governed by the Organizer's General Terms and Conditions of Use.
- 9. The Organizer's standard shipping fees apply to the Promotion. However, discounted shipping may also be available in specific cases during the Pepita Black Weeks.

The Organizer will communicate the detailed terms of the shipping discounts to the customer in a clear and transparent manner during the checkout process.

- 10. During the Pepita Black Weeks, the Organizer only accepts orders placed by the customer on the pepita.com website.
- 11. The Organizer does not provide an option for the customer to modify the shipping and billing information after the order has been placed. However, this does not affect customer requests for the subsequent modification of invoice details.
- 12. During the Promotion, the Organizer will indicate the expected delivery time for each product under normal business operations, which is a maximum of 10 business days. Due to the increased order volume during the Pepita Black Weeks period, this delivery time may be extended by up to an additional 10 business days, of which the Organizer will inform customers in advance on the product page or during the ordering process. The Organizer undertakes to ensure that the delivery of the specific product occurs within the indicated expected delivery time, taking into account the specified extension. Due to the increased traffic, it may happen that information about an actual extension of the delivery time is only provided after the delay has occurred; however, the Organizer strives to notify the customer in such cases as soon as possible.
- 13. The Organizer considers as force majeure any cause, event, or circumstance that affects the execution of the Pepita Black Weeks, is beyond its control, and which it cannot foresee, avoid, or overcome, or which cannot be reasonably expected of it as a company operating an online marketplace, and the occurrence of which makes it impossible for the Organizer to fulfill, in whole or in part, the obligations set forth in these Regulations. The Organizer also considers it a force majeure event if its IT network slows down or becomes unavailable due to

increased traffic. The Organizer excludes its liability in respect of force majeure events. The Organizer undertakes to inform affected customers of a force majeure event without delay via email or telephone.

- 14. Within the framework of the Promotion, the Organizer applies the data processing rules as set out in its General Terms and Conditions of Use and does not establish any deviating provisions.

- 16. The Organizer reserves the right to terminate, withdraw, or change the announced conditions of the Promotion at any time, without justification, subject to the simultaneous notification of customers on the pepita.com website.
- 17. The Organizer informs its customers that it operates as an online marketplace, which means that it also displays the commercial communications of other sales partners, and it is possible to conclude contracts with these sales partners through the pepita.com website. In the case of contracts where the Organizer is not indicated as the seller during the sale, the customer enters into a contractual relationship with our merchant partner specified during the purchasing process.
- 18. Unless otherwise specified in these Regulations, the Organizer's General Terms and Conditions of Use and the relevant Hungarian laws shall apply to the Promotion. The Organizer's General Terms and Conditions of Use are available at https://pepita.com/en/terms-of-use.
